TERMS AND CONDITIONS

TUITION

Tuition is due by the end of every month (30th, 31st). A late fee of \$50.00 will be added to your account if payment of all amounts due is not received by the 1st business day of the month following.

ELIGIBILITY AND EMERGENCY CARD

An Emergency Card must be on file with the Explorer Program prior to the first day of attendance. The Explorer Program requires that the child must be entering 1st grade-5th grade.

FIELD TRIPS, ACTIVITIES, AND LIABILITY

I give the Explorer Program permission for my child to take part in all school activities, including bus trips, sports activities, and field trips away from the premises. I agree to hold the school and its agents harmless for any liability to my child, or guardian, or parent thereof because of any claims on behalf of my child against the school or any agent thereof because of any injury or alleged injury to my child. Should legal action for any reason be taken against Explorer Program, any employee, or agent thereof on my child's behalf and the school or its agent is not at fault, I agree to pay any attorney fees, court fees, damages, or other costs that The Explorer Program or its agent should incur to defend itself against such action.

I give the Explorer Program permission to take my child off premises should an evacuation be necessary _____ (initial)

If my child attends school the day of a scheduled field trip, I give my permission for the field trip regardless of whether I sign a field trip notice. If I do not want my child to participate on the day of a scheduled field trip, I will withhold my child from school during the hours scheduled for the field trip. No childcare will be available for children not participating in a field trip. _____ (initial)

PHOTOGRAPHS

I give my permission for my child's picture to be taken while attending the Explorer Program _____ (initial)

CANCELLATION OF CONTRACT

This contract may be terminated by the parent or legal guardian for any reason whatsoever with a 2-week written notice. However, this contract may be terminated by the Explorer Program immediately, from date of enrollment for 1) behavioral issues or problems associated with school environment determined by the Explorer Program in its sole discretion; 2) delinquent accounts; 3) if parent/legal guardian and staff are unable to work together in a positive, cooperative manner; or 4) if the room in which your child attends becomes unusable due to a natural disaster or other unforeseen event.

REFUNDS AND FEES

Refunds may be given on a case-by-case basis with 2 weeks notice. In the event you have overpaid tuition, the credit will be applied to your next month's tuition. If on the final day of your child's attendance you have a balance, a refund will be issued. There is a \$1 a min charge for late pick-up.

HANDBOOK

I have read and agree to the Parent Handbook. I understand that rules and regulations found in the handbook may be modified from time to time and that as long as my child is enrolled at the Explorer Program, I agree to follow and support the guidelines therein. I understand that the standards of the school are consistent with the literal interpretation of the Bible and do not, in part, tolerate obscenity in word or action, dishonor to God or the Word of God, disrespect to the Explorer Program personnel, or continued disobedience to the established policies of the Explorer Program. _____ (Initials)
